

# **RAFFLE LICENSES**

## **INFORMATION REQUIRED ON TICKET**

### **AWARDING MERCHANDISE:**

- A. When tickets are sold for an off-premises raffle awarding merchandise as a prize, each ticket shall contain at least the following information:
  1. Name and identification number of the qualified organization and number of the license issued for occasion;
  2. Place where the occasion will be held and the date and time thereof;
  3. A list of the prizes and the retail value of each;
  4. The number of the tickets;
  5. Price of the ticket;
  6. The purpose to which the entire net proceeds will be devoted;
  7. The statement: "No substitution of the offered prize may be made and no cash will be given in lieu of the prize".
- B. The presence of the holder of a ticket shall not be required in order to win unless the ticket bears the statement "NOT VALID UNLESS HOLDER IS PRESENT AT THE DRAWING".
- C. The stub or counterpart of each ticket shall bear the name and address of the holder, the number of the ticket, the raffle license number issued for the occasion and the identification number of the licensed organization.
- D. All information required by A, B, and C, above shall be clearly and conspicuously set forth on the face of the ticket.

### **AWARDING CASH:**

- A. When tickets are sold for an off-premises raffle awarding cash or money as a prize, each ticket shall contain at least the following information:
  1. Name and identification number of the qualified organization and number of the license issued for the occasion;
  2. Place where the occasion will be held and the date and time thereof;

3. The statement: "This is a 50/50 cash raffle and the winner will receive 50 percent of the amount received for all tickets or rights to participate";
  4. If the prize pool is to be divided among multiple winners, the ticket must indicate the percentage of the prize pool that each winner will receive;
  5. The number of the ticket;
  6. Price of the ticket;
  7. The purpose to which the entire net proceeds will be devoted;
  8. The statement: "No substitution of the offered prize may be made".
- B. The presence of the holder of a ticket shall not be required in order to win unless the ticket bears the statement "NOT VALID UNLESS HOLDER IS PRESENT AT THE DRAWING".
- C. The stub or counterpart of each ticket shall bear the name and address of the holder, the number of the ticket, the raffle license number issued for the occasion and the identification number of the licensed organization.
- D. All information required by A, B, and C above shall be clearly and conspicuously set forth on the face of the ticket.

## **PROHIBITED PRIZES**

---

**No license shall offer or award any prize consisting of:**

Real estate or an interest therein;  
Bonds;  
Shares of stock;  
Securities or evidence of indebtedness;  
Weapons;  
Live animals;  
Personal or professional services;  
Alcoholic Beverages;  
Foreign or domestic coins;  
Tobacco products;  
Motor vehicles leases or;  
Any merchandise refundable in any of the foregoing or in money or cash

**A prize consisting of money or cash shall not be offered or awarded except in the case of:**

1. A raffle conducted by drawing with the prize(s) equaling 50 percent of the amount received for all the tickets or rights to participate, a calendar raffle within the limits set in N.J.A.C. 13:47-8.22; an instate raffle game within the limits set forth in this Chapter; or
2. Any bingo game(s) conducted in accordance with the provisions of this chapter and the Bingo Licensing Law, N.J.S.A. 5:8-24 te seq.; or
3. Big six wheels and horse race wheels conducted in accordance with the provisions set forth in N.J.A.C. 13:47-8.

## **RAFFLE PRIZE LIMITS**

---

<b><u>Off-Premises Draw Raffles</u></b>	\$100,000 per raffle and \$500,000 annually
<b><u>Non-Draw Raffles</u></b> (Carnival Wheels and Games)	\$500 per prize
<b><u>Instant Raffle Tickets</u></b>	\$500 per prize
<b><u>Calendar Raffles</u></b>	\$25,000 per calendar
<b><u>Golf Hole-in-One Contest</u></b>	\$1,000,000 For grand prize hole-in-one \$500 per ancillary prize (wholly donated prizes exempt from \$500 limit)
