**ORDINANCE 02-2026**

**AN ORDINANCE EXCEEDING THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND  
ESTABLISHING A CAP BANK IN CALENDAR YEAR 2026 (N.J.S.A. 40A:4-45.14)**

**WHEREAS**, the Local Government Cap Law, N.J.S.A 40A:4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and

**WHEREAS**, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and

**WHEREAS**, the governing body of the Township of Mullica, County of Atlantic, State of New Jersey, finds it advisable and necessary to increase its CY 2026 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and

**WHEREAS**, the Mayor and Committee hereby determines that a 3.5% increase in the budget for said year, amounting to \$84,133.68 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law is advisable and necessary; and

**WHEREAS**, the Township Committee hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

**NOW, THEREFORE, BE IT ORDAINED**, by the Township Committee of the Township of Mullica, County of Atlantic, State of New Jersey, that a majority of the full authorized membership of this governing body, affirmatively concurring, that in the CY 2026 budget year, the final appropriations of the Township of Mullica shall, in accordance with this ordinance and N.J.S.A. 40A:4-45.14, be increased by 3.5 %, amounting to \$5,805,224 and that the CY 2026 municipal budget for the Township of Mullica be approved and adopted in accordance with this ordinance.

**BE IT FURTHER ORDAINED**, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

**ENGINEER'S REPORT**

1. **NJDOT FY2025 Municipal Aid: Burdick Ave. & Wharton Park Blvd. Roadway & Drainage Improvements**  
(ARH Proj. # 62-01015.01)
  - Pending comments from NJDOT. ARH to address any comments received and prepare to bid in the 1<sup>st</sup> quarter of 2026.
2. **New Police Building Site** (ARH Proj.# 6201001.03)
  - On-going internal coordination meetings with architect and engineer to confirm technical details regarding proposed site improvements and building addition.
  - Pinelands submission is under review. Will address comments upon receipt.
  - Target submission to Atlantic County Health Department by end of January.
  - Anticipating to bid the project in 1<sup>st</sup> quarter of 2026.
3. **NJDOT State Aid Grants, FY2026 (ARH# P2025.0402)**
  - FY26 Municipal Aid – 4<sup>th</sup> Avenue Roadway & Drainage Improvements
    - o Grant amount is assigned and is valued at \$231,023.00 excluding design and management fees.
    - o Proposal is sent to the Township for their consideration and budget allocation for 2026.
  - FY26 Safe Streets to Transit – Wharton Park Boulevard Sidewalk and Pedestrian Safety Improvements
    - o This application is not awarded to the Township.
4. **River Road Survey Support**
  - Revised proposal forwarded to the Township and will be considered and issued a PO once agreed and finalized.
5. **2024 Stormwater Pollution Prevention Plan**
  - NJDEP provided approval for the updated plan submitted in December 2025. The Township will receive the remaining grant funds (\$50,000) based on this acceptance by the NJDEP to be used for stormwater management compliance.
6. **Road Opening Permits**
  - None issued for this month.
7. **Interim Zoning Officer**
  - On-going and coordinating applications with the Construction & Zoning Department.
8. **2024 State Aid Highway Improvement Projects (Lower Bank Road)**
  - ARH Associates attended the pre-construction meeting on 1/14/2026.
  - Lower Bank Road is scheduled to undergo improvements for drainage, milling and asphalt overlay.
  - Schedule is not finalized but anticipated to commence in early Spring. Work along Lower Bank Road is anticipated to be two (2) to four (4) weeks.

**Supporting an Amendment to the Atlantic County Solid Waste Management Plan  
Endorsing the Expansion of the ACUA Landfill at the  
Howard "Fritz" Haneman Environmental Park**

**WHEREAS**, the Atlantic County Utilities Authority ("ACUA") provides solid waste disposal services for Atlantic County municipalities, ensuring reliable, transparent, and environmentally responsible management of the region's solid waste;

**WHEREAS**, waste generated within Atlantic County is currently disposed of at the landfill located at Howard "Fritz" Haneman Environmental Park, located at 6700 Delilah Road, Egg Harbor Township, New Jersey;

**WHEREAS**, the existing landfill currently is project to reach disposal capacity by 2029

**WHEREAS**, the ACUA has proposed an expansion of the existing landfill that includes a horizontal expansion of approximately 5.74 acres and a vertical expansion of approximately 40 feet, which together will provide an estimated eleven (11) additional years of disposal capacity, extending the landfill's useful life to approximately 2040;

**WHEREAS**, the continued operation of the ACUA landfill is essential for maintaining stable and predictable disposal rates for municipalities, helping local governments budget effectively and protect taxpayers from unexpected cost increases;

**WHEREAS**, ACUA's publicly governed structure ensures full transparency, public accountability, and open decision-making regarding waste management operations, capital planning, and environmental compliance;

**WHEREAS**, ACUA operates under stringent environmental regulations and employs best-practice landfill engineering, environmental monitoring, and sustainability initiatives, making the expansion the most environmentally responsible option for the long-term management of Atlantic County's solid waste;

**WHEREAS**, relying on ACUA for solid waste disposal avoids the uncertainties, environmental impacts, and significantly higher long-term costs associated with transporting waste to out-of-county or out-of-state facilities;
